- Using the Shield Mark or LBHXX Mark in connection with the a. manufacturing, importing, exporting, distributing, licensing, selling, marketing, advertising, promoting, or offering for sale of any goods or services;
- b. Performing any act likely to tarnish or dilute the distinctive quality of the Shield Mark;
- Registering or seeking to register the Shield Mark or LBHXX c. Mark with any domestic or foreign agency, including but not limited to the United States Patent and Trademark Office ("USPTO");
