1 This action having been commenced on August 4, 2014, and the Court having  
2 approved the stipulation for entry of judgment in favor of plaintiffs Trustees of the  
3 Southern California Pipe Trades Health and Welfare Trust Fund, et al., and against  
4 defendants Mission Valley Landscape Co. and Daniel C. Vasquez, and for good cause  
5 shown,

7 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

8 Plaintiffs Trustees of the Southern California Pipe Trades Health and Welfare  
9 Trust Fund, Trustees of the Southern California Pipe Trades Pensioners and Surviving  
10 Spouses Health Fund, Trustees of the Southern California Pipe Trades Retirement Trust  
11 Fund, Trustees of the Southern California Pipe Trades Defined Contribution Trust Fund,  
12 Trustees of the Southern California Pipe Trades Vacation and Holiday Trust Fund,  
13 Trustees of the Southern California Pipe Trades Christmas Bonus Fund, Trustees of the  
14 Apprentice and Journeyman Training Trust Fund, Trustees of the Plumbers and  
15 Pipefitters National Pension Fund and Trustees of the International Training Fund shall  
16 recover from defendants Mission Valley Landscape Co. and Daniel C. Vasquez, jointly  
17 and severally, the principal amount of \$32,338.69, plus pre-judgment and post-judgment  
18 interest thereon at the rate of eight percent (8%) per annum from September 5, 2014,  
19 until paid in full.
