The Court has engaged in de novo review of those portions of the Report to which Petitioner has objected. The Court accepts the 20 21 findings and recommendation of the Magistrate Judge. 22 In his objections to the Report, Petitioner also requests an evidentiary hearing. However, in habeas proceedings, "an evidentiary hearing is not required 23 24 on issues that can be resolved by reference to the state court record." Totten v. Merkle, 137 F.3d 1172, 1176 (9th Cir. 1998); see also Earp v. Ornoski, 431 F.3d 1158, 25 1173 (9th Cir. 2005). "It is axiomatic that when issues can be resolved with 26 reference to the state court record, an evidentiary hearing becomes nothing more 27 than a futile exercise." Totten, 137 F.3d at 1176. Here, the Magistrate Judge 28

1	concluded all of Petitioner's claims could be resolved by reference to the state
2	court record. Accordingly, the Court denies Petitioner's request for an evidentiary
3	hearing.
4	IT IS THEREFORE ORDERED that Judgment be entered (1) denying the
5	Petition for a Writ of Habeas Corpus; and (2) dismissing this action with prejudice.
