1 For good cause shown, and in accordance with the concurrently submitted
2 Joint Stipulation, the Court finds that:

3 1. On December 29, 2017, the Court granted Defendants' Motions to
4 Dismiss, and dismissed Winter's Second Amended Complaint with prejudice, with
5 the exception of a retaliation claim under 31 U.S.C. § 3730(h) against unserved
6 defendant GARDENS REGIONAL MEDICAL CENTER, INC. ("Gardens
7 Regional"). Document No. 149.

8 2. On January 30, 2018, Winter voluntarily dismissed her retaliation
9 claim under 31 U.S.C. § 3730(h) against unserved defendant Gardens Regional.
10 Document No. 161.


11 3. On February 7, 2018, the Court denied a Joint Motion for Attorneys'
12 Fees by defendants RollinsNelson, Nelson, Rollins, Weiner, S&W, and Dr.
13 Pascual. Document No. 163.

14 4. There are no more outstanding claims or motions currently before this
15 Court on the above-captioned case.

16 Pursuant to Federal Rules of Civil Procedure, rule 58(a), (b)(2)(B), (d), and
17 the parties' joint request, the Court hereby enters judgment in favor of defendants,
18 such that all relief requested in Winter's Second Amended Complaint is denied.
19 The Clerk shall enter judgment as described herein pursuant to Civil Local Rule
20 58-4.
