

2 to Show Cause Re: Contempt of Court, which counsel has subsequently done.

3 **IT IS HEREBY ORDERED** that the principal of Plaintiff ADVANCED
4 CLEANUP TECHNOLOGIES, INC., namely RUBEN GARCIA, who is the Chief
5 Executive Officer, Secretary, Chief Financial Officer and Director of the Plaintiff
6 corporation, shall appear before the Hon. Judge Christina A. Snyder in Courtroom
