7 Plaintiffs Trustees of the Southern California Pipe Trades Health and Welfare  
8 Trust Fund, Trustees of the Southern California Pipe Trades Retirement Trust Fund,  
9 Trustees of the Southern California Pipe Trades Defined Contribution Trust Fund,  
10 Trustees of the Southern California Pipe Trades Vacation and Holiday Trust Fund,  
11 Trustees of the Southern California Pipe Trades Christmas Bonus Fund, Trustees of the  
12 Apprentice and Journeyman Training Trust Fund, Trustees of the Southern California  
13 Pipe Trades Pensioners and Surviving Spouses Health Fund, Trustees of the Plumbers  
14 and Pipefitters National Pension Fund, and Trustees of the International Training Fund,  
15 shall recover from Defendants JMS Air Conditioning and Appliance Service, Inc. and

17 post-judgment interest calculated at 8% per annum from May 1, 2018, until paid in full.
