 26 Upon the Stipulation of the parties, by and through  
 their counsel, the Court finds and orders as follows:

1           1.    Visual Entertainment, Inc. ("VEI") has sued the  
2 defendants arising out of agreements between VEI and Millennium  
3 Entertainment, LLC ("MILLENNIUM").

4           2.    By and through their counsel, the parties stipulate  
5 to an Order that provides that defendant Bill Lee ("LEE") and  
6 Virgo Investment Group, LLC ("VIRGO") are to be dismissed without  
7 prejudice and by this Order, the Court dismisses defendants LEE  
8 and VIRGO without prejudice.

9           3.    By and through their counsel, the remaining  
10 parties, VEI and Our Alchemy, LLC ("ALCHEMY") f/k/a MILLENNIUM,  
11 have stipulated to an Order to arbitrate the claims asserted in  
12 the Complaint. This Court orders and directs that plaintiff VEI  
13 and defendant ALCHEMY are to arbitrate the disputes between them  
14 before JAMS Los Angeles, 555 West Fifth Street, 32nd Floor, Los  
15 Angeles, CA 90013, before a single arbitrator in accordance with  
16 JAMS Comprehensive Arbitration Rules and Procedures.

17           4.    The Court orders this case to be placed on the  
18 inactive list. The Court will retain jurisdiction to enforce its  
19 Order directing arbitration and to confirm the arbitrator's award.
