22 Before the Court is Plaintiff Phillips 66 Company’s Motion for Final  
 23 Summary Judgment against Thomas Helo. After consideration of the papers in  
 24 support of and in opposition to Plaintiff's motion for summary judgment, the  
 25 pleadings and papers on file, and any arguments of counsel and *pro se* defendant  
 26 Thomas Helo, the Court orders summary judgment in favor of Phillips 66  
 27 Company as follows:  
 28

- 1           1.   Phillips 66 Company is owed the amount of \$285,025.89 by Thomas  
2           Helo;
- 3           2.   Phillips 66 Company is entitled to prejudgment interest against Thomas  
4           Helo at the rate of \$47.95 per day from March 28, 2012 to May 3, 2016,  
5           in the amount of \$71,779.28;
- 6           3.   Phillips 66 Company is entitled to additional prejudgment interest  
7           against Thomas Helo at the rate of \$47.95 per day from May 4, 2016 to  
8           the day before the date of this judgment;
- 9           4.   Phillips 66 Company is entitled to post-judgment interest against  
10          Thomas Helo from the date of this judgment in accordance with 28  
11          U.S.C. § 1961;
- 12          5.   Phillips 66 Company is entitled to reasonable attorney's fees against  
13          Thomas Helo in the amount of \$168,401.95 and litigation expenses  
14          against Thomas Helo in the amount of \$1,178.65; and
- 15          6.   Phillips 66 Company is entitled to costs of court.
- 16          7.   Phillips 66 is entitled to all writs and process necessary to enforce and  
17          collect this judgment.
- 18          8.   This judgment finally disposes of all remaining parties and all  
19          remaining claims, and is appealable.
