 23 The motion of defendants State of California, acting by and through the
 24 California Highway Patrol (CHP), CHP Officer Jon Relles and CHP Officer Todd
 25 Barrett for Summary Judgment or, in the Alternative, for Partial Summary Judgment
 26 and the motion of defendant Howard Sommers Towing, Inc. for Summary
 27 Judgment, or, in the Alternative, Partial Summary Judgment came on regularly for
 28 hearing before this Court on October 17, 2016. The Court, having fully considered

1 the evidence presented and having heard oral argument, issued an Order granting
2 both motions in their entirety, finding that defendants State of California, acting by
3 and through the CHP, CHP Officer Relles, CHP Officer Barrett and Howard
4 Sommers Towing, Inc. are entitled to summary judgment on all claims asserted by
5 plaintiff Metal Jeans, Inc.

6 Therefore, IT IS HEREBY ORDERED AND ADJUDGED THAT plaintiff
7 Metal Jeans, Inc. take nothing in this action, that the action by plaintiff Metal Jeans,
8 Inc. against defendants State of California, acting by and through the CHP, CHP
9 Officer Jon Relles, CHP Officer Todd Barrett and Howard Sommers Towing, Inc.
10 be dismissed on the merits, and that defendants State of California, acting by and
11 through the CHP, CHP Officer Jon Relles, CHP Officer Todd Barrett and Howard
12 Sommers Towing, Inc. recover their costs.
