27 On February 7, 2018, the parties filed a stipulation requesting a complete

28 resolution of the total amount of the judgment and award of costs and attorneys'

1 fees, in the form of a judgment against the County of Los Angeles and Deputy  
2 Ruben Rivera, in the total amount of \$537,717.55, inclusive of all damages,  
3 attorneys' fees and costs.

4 Pursuant to the stipulation by the parties and good cause appearing therefor,  
5 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED:**

- 6 1. That the plaintiff shall have and recover from the County of Los  
7 Angeles and Deputy Ruben Rivera the total sum of \$537,717.55, said  
8 amount to be inclusive of all damages, attorneys' fees and costs.
- 9 2. That the County of Los Angeles shall pay the plaintiff, Mirko Hoffman  
10 and the firm Wagner & Pelayes, LLP, the sum of \$100,000 and shall  
11 issue a separate payment to the law firm of Wagner & Pelayes, LLP, in  
12 the sum of \$437,717.55.
- 13 3. Upon payment, the plaintiff shall file a notice with this court.
- 14 4. This court retains jurisdiction over this case until such time as the terms  
15 of this order have been completed.
