On March 9, 2017, the jury entered their verdict with respect to all claims in these consolidated actions. On March 31, 2017, this Court entered Judgment with respect to all claims. On July 20, 2017, this Court entered an order amending the Judgment to include awards of prejudgment interest and attorney’s fees as set forth therein.

1           **IT IS NOW, THEREFORE, HEREBY ORDERED, ADJUDGED AND**  
2 **DECREED** as follows:

3           1.       Judgment is entered in favor of Sinofreight, LLC (“Sinofreight”) and  
4 against Gerber Plumbing Fixtures, LLC (“Gerber”) in the amount of \$79,416.36  
5 with respect to Sinofreight’s claim for Common Counts against Gerber (consisting  
6 of \$46,249.09 in damages, \$21,803.97 in prejudgment interest and \$11,363.30 in  
7 attorney’s fees).

8           2.       Judgment is entered in favor of Cathay Logistics, LLC (“Cathay”) and  
9 against Gerber in the amount of \$322,296.95 with respect to Cathay’s claim for  
10 Common Counts against Gerber (consisting of \$288,775.00 in damages, \$32,321.95  
11 in prejudgment interest and \$1,200.00 in attorney’s fees).


12           3.       Judgment is entered in favor of Gerber and against Amerifreight, Inc.  
13 dba Logistics Team (“Logistics Team”) in the amount of \$1,016,796.97 with respect  
14 to Gerber’s claim for Breach of Contract against Logistics Team (consisting of  
15 \$280,587.00 in damages, \$47,815.10 in prejudgment interest and \$688,394.87 in  
16 attorney’s fees).

17           4.       Judgment is entered in favor of Gerber and against 19201 Reyes, LLC  
18 (“19201 Reyes”) with respect to Gerber’s claim for conversion against 19201 Reyes.

19           5.       Judgment is entered in favor of Gerber and against 19201 Reyes,  
20 Logistics Team, Cathay and Sinofreight with respect to Gerber’s claim for  
21 Conspiracy to Commit Conversion.
