2 Conference, Motion to Remand, and Motion to Dismiss and for good cause shown,
3 it is hereby ordered that:

4 The Rule 26(f) Scheduling Conference and the hearings on plaintiffs' motion
5 to remand and defendants' motion to dismiss, currently scheduled for December 7,
