
1 Defendant the U. S. Small Business Administration, an agency of the United
2 States Government (“SBA”), who originally removed this case to this Honorable
3 Court, having filed a Disclaimer of Interest for purposes of this action, disclaiming
4 all right, title and interest in the property sought to be taken by Plaintiff Metro.
5 (Doc. No. 11); and

6 Plaintiff Los Angeles County Metropolitan Transportation Authority
