4	FSB, f/k/a World Savings Bank, FSB ("Wells Fargo") (erroneously sued as "World
5	Savings Bank, FSB dba Federal Savings Bank"; "Wells Fargo Bank, National
6	Association") and GOLDEN WEST SAVINGS ASSOCIATION SERVICE CO.
7	(Golden West"), dismissing the Complaint in its entirety.
8	Accordingly:
9	IT IS HEREBY ORDERED, ADJUDGED AND DECREED:
10	1. The Complaint is dismissed, as to all causes of action, with prejudice;
11	2. Judgment is entered in favor of defendants WELLS FARGO BANK,
12	N.A. and GOLDEN WEST SAVINGS ASSOCIATION SERVICE CO.; and
13	3. Plaintiffs, Pablo Duran and Maria Duran will recover nothing in this
14	action from defendants WELLS FARGO BANK, N.A. and GOLDEN WEST
15	SAVINGS ASSOCIATION SERVICE CO.
