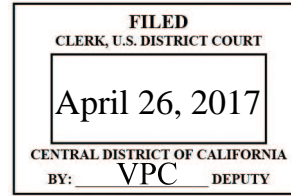

 21 **JUDGMENT**

22 On April 14, 2017, the Court considered the application of Plaintiff PAZ GAMING, INC.  
 23 (“PAZ”) for a default judgment against Defendant RCD HOLDINGS LTD., an Australian  
 24 company (“RCD”), under Federal Rules of Civil Procedure, Rule 55(b)(2) (the “Application”).

25 After considering the papers submitted in support of the Application, and the papers on  
 26 file in this action, the Court finds as follows:

- 27 1. Defendant RCD has failed to appear in this action by timely pleading or  
 28 responding to, or otherwise defending against, the complaint in this action after  
 being properly served with that complaint. Accordingly, the clerk entered default  
 against Defendant RCD on February 13, 2017.
2. Defendant RCD is a business entity and is not serving in the military, is not a

1 minor or incompetent person, is not an officer of agency of the United States, and  
2 is not a foreign state or a political subdivision, agency, or instrumentality of a  
3 foreign state.

- 4 3. Defendant RCD is liable to Plaintiff PAZ in the amount of \$560,000.00 due to  
5 RCD's interference with PAZ's contract with DEQ.
- 6 4. Plaintiff PAZ is awarded attorney's fees in the amount of \$14,800.00
- 7 5. Plaintiff is awarded its legal costs, in the amount of \$1,307.00, in accordance with  
8 the Application to Tax Costs filed herein.
