1 Plaintiff, Ascentium Capital, LLC, a Delaware limited liability company
2 ("Plaintiff"), on the one hand, and Defendants and Cross-Claimants, Robert James
3 Houchin, DDS, a professional dental corporation ("Houchin Corp."), Robert J.
4 Houchin, DDS aka Robert James Houchin DDS aka Robert J. Houchin aka Robert
5 James Houchin ("Houchin", and together with Houchin Corp., collectively,
6 "Defendants"), on the other hand, having signed a written Stipulation for Entry of
7 Judgment (the "Stipulation") and the Stipulation having been filed herein, the Court
8 orders the following judgment pursuant to the Stipulation:

9 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that Plaintiff
10 is awarded Judgment against Defendants, and each of them, in the sum of
11 \$226,209.60 plus interest at the legal rate after entry of judgment on the First and
12 Second Claims in the Complaint.

13 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that all other
14 Claims are dismissed without prejudice.

15 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that
16 Defendants' cross-claims against Kenali, Inc., Ali Kalbassi, Dentalon, Inc. are
17 hereby dismissed with prejudice from this action, unless Defendants' cross-claims
18 against Kenali, Inc., Ali Kalbassi and Dentalon, Inc. have already been dismissed
19 with prejudice from this action.

20 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that all of the
21 terms and conditions set forth in the Stipulation are incorporated herein by this
22 reference.

23 THE CLERK IS ORDERED TO ENTER JUDGMENT FORTHWITH.
