2 approved the stipulation for entry of judgment in favor of plaintiffs, Trustees of the
3 Southern California IBEW-NECA Pension Plan, et al., and against defendants, M.L.
4 Alexander Electric Co., Inc., a California corporation doing business as “Alexander
5 Electric Company,” and for good cause shown,

6 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that Plaintiffs,
7 Trustees of the Southern California IBEW-NECA Pension Plan, Trustees of the
8 Southern California IBEW-NECA Defined Contribution Trust Fund, Trustees of the
9 Southern California IBEW-NECA Health Trust Fund, Trustees of the Southern
10 California IBEW-NECA Supplemental Unemployment Benefit Trust Fund, Trustees
11 of the Los Angeles County Electrical Educational and Training Trust Fund, Trustees
12 of the National Electrical Benefit Fund, Trustees of Southern California IBEW-NECA
13 Labor-Management Cooperation Committee, Trustees of the National NECA-IBEW
14 Labor-Management Cooperation Committee Trust Fund, National Electrical Industry
15 Fund, and Los Angeles Electrical Workers Credit Union, shall recover from Defendant
16 M.L. Alexander Electric Co., Inc., a California corporation doing business as
17 “Alexander Electric Company,” the principal amount of \$85,958.79, together with pre-
18 judgment and post-judgment interest at the rate of 8% per annum accruing from
19 February 10, 2017, until the judgment is paid in full.
