

6 GOOD CAUSE exists to issue a protective order to protect the trade secrets  
7 or other confidential research, development, or commercially propriety or  
8 sensitive business information not be revealed or only to be revealed in a specified  
9 way, specifically including: (a) the Settlement Agreement by which Certain  
10 Underwriters at Lloyd’s, London paid money in satisfaction of the judgment  
11 entered against B&G Development, Chris Bredesen and Virginia Bredesen in the  
12 underlying *Elizabeth Brandt v. B&G* lawsuit, (b) insurance claim manuals and
