JUDGMENT GRANTING APPROVAL
OF MINOR’S COMPROMISE OF
CLAIMS

1 This Court, having considered the minor Plaintiff T.T.'s Petition for Approval of
2 Minor's Compromise, filed by Melissa Govea, guardian ad litem for minor Plaintiff T.T.
3 on November 6, 2018 (Dkt. No. 63), and finding **GOOD CAUSE** as set forth in the
4 Court's December 6, 2018 Order Granting the Petition for Approval of Minors'
5 Compromise (Dkt. No. 64),

6 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** as follows:

7 1. The aggregate amount offered in compromise to GOVEA and T.T. is
8 \$40,000.00;

9 2. Although GOVEA is a named party to this action, GOVEA will not partake
10 in any part of the settled amount, and the entirety of the settled amount will be apportioned
11 only to T.T.;

12 3. The entirety of the settled amount will be placed in a blocked bank account
13 held in the benefits of T.T., and the funds will be released upon the date T.T. reaches the
14 age of majority;

15 4. Abir Cohen Treyzon Salo, LLP will not seek its attorneys' fees from T.T.'s
16 settlement amount, but are entitled to its cost in the amount of \$1,156.61;

17 5. No additional fees or costs will be deducted from the gross settlement aside
18 from the \$1,156.61 in costs;


19 6. The net settlement payable to T.T. is in the amount of \$38,843.39 and shall
20 be deposited in an interest-bearing federally insured blocked account belonging to minor
21 T.T. No withdraw of principal or interest shall be made from the blocked account without
22 a written order from the Court until the minor reaches the age of majority.

23 7. Petitioner and *guardian ad litem* GOVEA is authorized and directed to
24 execute any and all documents reasonably necessary to carry out the terms of this Order.
