**ORDER RE STIPULATION
 WITHDRAWING NOTICE OF
 REMOVAL OF CIVIL ACTION AND
 REMANDING ACTION TO STATE
 COURT**

1 Having reviewed the stipulation of plaintiff Freedom Magnet, LLC (“Plaintiff”)
2 and defendants Performance Health Systems, LLC and Lee S. Hillman (collectively
3 “Defendants”) withdrawing Defendants’ prior Notice of Removal and remanding this
4 action to state court, and good cause appearing therefor, IT IS HEREBY ORDERED
5 THAT:

- 6 1. Notice of Removal (Dkt. No. 1), filed on May 8, 2017 by Defendants is
7 vacated and withdrawn in light of the parties’ agreement that Plaintiff’s
8 Complaint is amended to dismiss the Third Claim for Relief against
9 Defendants, without prejudice;
- 10 2. This action, in its entirety, is remanded back to the state court from which
11 it was removed, specifically the Superior Court of the State of California
12 for the County of Los Angeles, West Judicial District, Dept. O, Hon. Lisa
13 Hart Cole (Original Case No. SC127323);
- 14 3. The parties will bear their own attorneys’ fees and costs incurred in
15 connection with the removal and remand of this action; and
- 16 4. The court file in this case shall be transferred by the clerk of this Court to
17 the clerk of the aforementioned state court, along with a certified copy of
18 this Order of Remand. The state court may thereupon proceed with this
19 case.
