

During the investigation process BRANDON A. FAVOR waived his constitutional right and answered Network Detective(s) Weber/Ries formed question, BRANDON A. FAVOR waived his right of silence solely by the unknowingly knowledge of position, binded, in light by duress, by the accused suspect's.

Upon November 8, 2004 BRANDON A. FAVOR were on Crenshaw Boulevard by leaving a commissary store, once Mr. FAVOR passed 4287 Crenshaw Blvd walking south of Crenshaw, Mr. FAVOR viewed two African-American males standing in presence upon 4289 1/2 Crenshaw Blvd, he recognized one of the two males as "Jay-Bird" the additional individual he had no knowledge of, the two males began to follow Mr. FAVOR immediately once Mr. FAVOR acknowledged "Jay-Bird", Mr. FAVOR immediately became uncomfortable an sensed danger coming forth, in turn, Mr. FAVOR viewed a male (African-American) whom he'd knowledge of as "Trub", Mr. FAVOR then jumped over a small wall to alert "Trub" of his suspicion of the two following.

"Trub" recognized instantly the body language of the

awaiting men, Mr. Faver suggested to "Tub" to bring the two men to a (convenient) liquor store. (a store made appearance by Mr. Faver and "Tub" early in the morning while attending the County Service building/units), "Tub" did not respond, he remained in view of the two males.

Mr. Faver then jumped over the small wall located to be the BLOCKBUSTER VIDEO

parking lot, he spoke shortly to "Jay-Bird" in reference to the store, after "Jay-Bird" agreed, Mr. Faver then asked if they had a gun, the second male made a gesture as to state a weapon was located upon the right side of his waist. band, Mr. Faver did not visually witness any form of weapon, however, Mr. Faver was not going to challenge the (strong) possibility.

Mr. Faver then directed his conversation unto "Jay-Bird" as to how to arrive by public transportation, Mr. Faver with the two males proceeded to await the METROPOLITAN TRANSPORTATION AUTHORITY NO. 10, located directly in entrance of the McDonald's located across from the BLOCKBUSTER VIDEO.

Once boarded Mr. Favor obtained the awareness of the African-American male driver, who became attentive of Mr. Favor's body language. Mr. Favor continues to have the male to speak with "Jay-Bird", Mr. Favor again enters A&T Liquor Store, during this moment Mr. Favor is creating his arrival to be present and acknowledged upon Mr. Favor's first entrance the store held no customer's about his seen and attempt to obtain the employee's attention, customer's begin to form on the store develops activity, the male to "Jay-Bird" are

Mr. Favor makes a purchase to obtain contact, the store employee (Now known as the late Pablo Castaneda) pays no attention to Mr. Favor, not obtaining facial recognition.

Mr. Favor once again, exits the store, then walking south of Hill Street crosses Adams in an attempt to escape, Mr. Favor is now between three (3) conversations, "Jay-Bird", the possible weapon carrier, and "Trub", being the store employees/customer's are in high dangers, given Mr. Favor is unknowing of their intention(s) he returns to A&J Liquor, entering to find "Jay-Bird" in which is observing the store, Mr. Favor then leads "Jay-Bird" out of A&J Liquor to displace his attention.

Mr. Favor then speaks to "Jay-Bird" outside of the store, the possible gun carrier is present as well, Mr. Favor attempts to lead the two men away from A&J Liquor only to return due to their wanting of financial gain, Mr. Favor then makes a FINAL attempt to pre-

Mr. Favor enters A&T liquor speaking a bit loud to attract attention again to store - warn its employees, as Mr. Favor begins to exit, "Jay Bird" and his companion view the security door is open then together cross the entrance of the entrance door, as Mr. Favor finally exit the two enter.

As Mr. Favor exits the store, standing outside the front entrance door is slammed shut, gun shots are heard in rotation, Mr. Favor first thought / action to run, Mr. Favor acknowledges that danger arises, Mr. Favor knocks on the stores door.

Mr. Favor enters A&T liquor, as he enters, he looks immediately to his right, Mr. Favor did not recognize "Jay Bird" as to whom opened the door, Mr. Favor then views the gunman standing over the deceased (Pablo Castaneda) in which Mr. Favor believed "Jay Bird" were standing directly behind the gunman, a cloud of white smoke (as to a mist) hung over the deceased

"you get all that money from?" Mr. Favor reply's to say "From a dice game!", the lady reply's "Be Careful", (the look in Mr. Favor's eyes told a different tale...)

Mr. Favor arrived on Crenshaw Blvd/ Homeland Drive, he contacts "Jay-Bird", "Jay-Bird" says he's not far on the bus, minutes later, "Jay-Bird" and the gunman arrive.

Mr. Favor then enters a soul food restaurant with the gunman and "Jay-Bird", the restaurant was closed being a monday, Mr. Williams is a well friend of Mr. Favor including his family, who in all part knows Mr. Favor is a well kept-respected, respectful young man.

Mr. Williams youngest son, seen Mr. Favor, "Jay-Bird" and the gunman, Mr. Favor took a seat followed by the two, once Mr. Favor began to spill large amounts of bills onto a table the youngest son became upset saying:

"YOU CAN'T BE DOING THIS SHIT HERE"

Mr Favor then walks to the storage room followed by the gunman and Jay-Bird...

Once inside, Mr Favor unloads the money onto the floor, Mr Favor then asked "Is this it?" (the gunman then gave off a demonic devilish grin.) Mr. Favor then counts out the money, it totals a little over one thousand dollars, Mr Favor then divides the money in which Bird" (gunman)...

The two exit out, Mr Favor takes the money and places it within his pants pocket and slowly leaves the restaurant, Mr Williams youngest son viewed Mr Favor not at his normal being!

Mr Favor makes a cellular phone store that carried clothing, the two followed Mr Favor unto his store located at 4283 Crenshaw Blvd, Mr Williams soul food restaurant "Daddy Daves and Big Momma's Cooking" is at 4287 Crenshaw Blvd, once inside, "Jay-Bird" displays a yellow bag in which contained the security video, Mr Favor places the cassette tape into a television and the tape displays a digital unformed image,

the tape contained an image finder, only to be played by its main control box and/or special equipment.....

Mr. Favor ejects the video, an "Jay-Bird" takes possession of it, Mr. Favor is behind his work station where "Jay-Bird" request a telephone Mr. Favor did not retain, Mr. Favor directs the two to a cell phone shop located down the street, Mr. Favor walks the two there, before the three leave, "Jay-Bird" gives "the yellow bag (containing the Security Tape) to Mr. Favor, Mr. Favor retains two T730 telephones, the two purchase the phones then leaves, as Mr. Favor walks down Crenshaw Blvd, "Jay-Bird" and the gunman head east on 43rd Street, Mr. Favor walks back to his business, Mr. Favor then stops to watch the two exit his view.....

Distorted, Mr. Favor returns to his store, after several minutes, opens the yellow bag to find the security tape and decides to throw it away, Mr. Favor places the tape into the trash can located in front of his business (the cities trash can).....

Mr. Favor discovered the A&T lower store cell-phone in his jean pocket and placed it into a storage bin filled with damaged phones...

Mr. Favor then exits the business. Mr. Favor leaves towards his girlfriend's apartment in Hawthorne, CA, once inside his mental state became unbalanced so he left shortly to return to Crenshaw / 43rd St.

After several days Mr. Favor began to grow ill, after several days of wearing the same clothes, Mr. Favor took a short D.A.S. H ride, he knew the female driver (Markeisha), Mr. Favor is usually full-spoken, witty, talkative. Today he is quiet and down, she asked "IS EVERYTHING OKAY / WHAT'S WRONG?", Mr. Favor replied "JUST THINKING", Markeisha replies "I HOPE EVERYTHING IS ALRIGHT!", Mr. Favor exits at the Crenshaw Plaza, walks towards his mother's apartment on Buckingham Road, he showered and changed clothing, he was no longer in low spirits...

(Mr. Favor prayed and left the solution of November 8, 2004 to GOD....)

Shortly within, "Jay-Bird" returns with the pre-paid phone cards and checks retained at A&T Liquor, he leaves it to Mr. Favor in exchange of cash money.

Mr. Favor didn't change the rejection of any prevention and sold one of the pre-paid cards, the checks he gave to an UNDISCLOSED SOURCE in exchange of \$150.00 -

"Jay-Bird" returned the following day and retained the cash money....

"Jay-Bird" were last seen on MLK Blvd/Western Ave, in which Mr. Favor were in route by public transportation with a lady friend.

The Gunman weren't seen after November 8, 2004....

"Trub" was given \$100.00 once Mr. Favor

returned from dividing the money with "Jay-Bird" and the gunmen, reason granted as UNKNOWN...

"Jay-Bird" were a black "SECURITY" jacket the day of November 8, 2004 -

It wasn't known that Mr. Favor was "high" (under the influence of a - controlled - substance) upon Marijuana (weed) and "X-Stacy" during the day of November 8, 2004...

In addition as well, Mr. Favor was under the influence during his detainment (upon June 13, 2005) by LOS ANGELES POLICE DEPARTMENT, Homicide Detective Calcan Abdul of Newton Division...

Mr. Favor began answering question's without integrity, initially proclaiming the individual shown within the states security system was not himself.

Detective Weber and Detective Elizabeth Rizzo continued to question Mr. Favor, Detective Weber's following statement, caused a change unto Mr. Favor's reason to not be truthful, in which were said:

MEMORANDUM

"IT SEEMS AS IF... YOU GET CAUGHT UP, IN SOME-
THING, YOU COULDN'T GET OUT OF... I DON'T
KNOW..."

Immediately once said, Mr. Favor became
clear as to admitting it was himself depicted
in the stores security system.

Due to Mr. Favor having no knowledge as to
why the two men ("Jay-Bird" / Gunman) began
to follow him, once Mr. Favor acknowledged

noon / evening disc jockey segment, Mr. Favor
then created a story, unpremeditated, yet, strictly
influenced by the controlled substance (Marijuana,
on the effects held by prior usage of "X-Stacy")
due to it's unknowing ("Jay-Bird" / Gunman)
sole cause of being present.....

Mr. Favor stated while at the Los Angeles Publi-
c Service Building (METRO GRANTS) he encounter-
ed the individual known as "Trub", Mr. Favor
then begins to state "Trub" said "he was going
to have his partner come over here".....?

(Mr. Faver then describes the takings once arrived to A & V Liquor Store)

Mr. Faver explained to Detective Weber & Rice (in parted truths) how he attempted to stop the robbery, he also stated once

he entered the store after several shots were fired, he knocked on the door to see what the hell is going on. Mr. Faver also states he grabbed phone-cards and opened the cash register after seeing people lying on the floor whom he thought were dead, Mr. Faver also stated he walked in the warehouse area...

Mr. Faver then continued to come partial conscious, yet remained under the influence, Mr. Faver was then being given the "Third Degree" by Detective Elizabeth Rice, Detect ive Rice wanted Mr. Faver to tell her who the gunman "SWICOTER" was and where he can be found...

Mr. Faver made forth attempts to con-

vience Detective Rico that he held no knowledge to the identity and whereabouts of the "SHOOTER".

Mr. Faver did not conceal his knowledge of "Jay-Bird" ("SECURITY", by the security jacket worn by suspect) and explained his knowledge of "Jay-Bird" by his father owning a barber shop/beauty salon ("MEL'S HOUSE OF STYLE") upon Western Avenue, one block of King Boulevard.

Mr. Faver did in fact have minor association with the locals to the area during his juvenile youth, yet sternly encouraged by his father to "RISE ABOVE".

Detective Rico continued to pressure Mr. Faver in light of the "SHOOTER".

Mr. Faver stated he possibly attended Crenshaw High School with the "SHOOTER". Mr. Faver was then transported to SOUTHWEST POLICE STATION to review the Crenshaw High School year book(s). the "SHOOTER" was not found nor located within.

Mr. Faver was then taken back to Newton Division and later transported to the local city jail for MURDER.

Sometime during the evening or late morning, Mr. Faver was transported to conduct a polygraph (after self-administration by Detective/Walder/Rice). Detective Youngblood of the LOS ANGELES POLICE DEPARTMENT conducted the polygraph exam, it was conducted twice, during the last/final exam, Detective Youngblood stated:

"JUST TELL THE TRUTH, SON"...

Mr. Faver became so excited that after Mr. Faver were then crying in an emotion-
al state.

Detective Walder requested to search Mr. Faver's home for the clothing were during the incident, Mr. Faver submitted willingly.

Detective Fanning and Thompson arrived to

4179 Buckingham Road, Apt # C, where they were met by the defendant's maternal parent (Reba Ann Stevens). Ms. Stevens then informed the Detectives that Mr. Favor had additional clothing items at his aunt (Michelle Stevens) apartment.

Detective Fanning and Thompson arrived immediately and were granted permission to search Mr. Favor's clothing. The jacket worn by Mr. Favor during the incident were located at the residence, no additional clothing were found.

Mr. Favor during the interview claimed to have thrown the clothes worn at the incident into the trash.

Mr. Favor also stated, the security tape watched by Mr. Favor, "Jay-Bird", and the Gunman, were thrown in a trash bin in the alley after being watched.

Mr. Favor stated fifteen hundred dollars were found in the cash register at A & T Liquor Store.

(Mr. Faver after exiting the bus upon Adams / Broadway, shortly after exchanging telephone frequency signals with "Jay-Bird" then the Gurnah, spoke briefly with "Jay-Bird" while walking to approach ABV Liquor) along Adams to Hill Street, Mr. Faver informed "Jay-Bird" as to his actions in the event he were addressed by law authorities, in which "Jay-Bird" did not find any form of objection during the short conversation.

Detective Tommy Thompson and Dennis Fanning returned to Newton Division Accompanied with the pocket watch by Mr. Faver during the November 8, 2004, ABV Liquor Store incident.

Mr. Faver was then questioned by Detective Frank Weber and Liz Rice, Mr. Faver did not explain the true facts portaken against him will during the day of November 8, 2004, prior towards his arrival at ABV Liquor Store.

Mr. Favor after questioning were granted a telephone call in which Reba Ann Stevens (Maternal Parent) awaited via: speakerphone:

"BRANDON, I KNOW YOU WOULDN'T KILL ANYBODY"

"DID YOU DO IT?" (Reba Ann Stevens)

"DO WHAT?" (Mr. Favor)
