





put it on camera I also told her what  
happen any they will be hearing from my lawyer  
3 days later I went to the infirmary for  
my finger the nurse said it was healing

if he can send me to 5,000 Flor so two  
sherriff's wate up and ask me if I was  
Chad Richie. They said the were gonna  
take me to 5,000 Flor I said yes while  
walking up the one of the Dees aske  
me why I was going to 5,000 Flor  
I said Im sprail ed as we entered  
2,000 Flor we went in to 2,200  
he opened the cell and he said go set  
you dug I said I had a lunch bag in  
the hall when I got the bag I  
seen the camera I reach and grab  
the bag and he closed the gate on  
my back I fdt heavy machinery like  
I got hit by a train he called me and  
said come here the next room had  
camera I looked and I Replied  
what do you want if you ren any

After 7 days I went to 5000 floor I asked the sergeant to go get the camera to take pictures of my bruises and once again I asked him for one injury report he told me that the injury report go in a little slot in the evidence room and it will be there for five years he told me that I had 10 years to sue they released me but when they did they forgot to lift the hold a year later I was arrested after I finished my program and again I was put in a position to take two years not knowing what was going on then I went to delano reception to finish out my 2 years my test scores was 1.2 table me mental retarded ~~and~~ leaving the hospital I was there all day on the 14th May I asked the C.O to feed me he did not so I asked again feed me at 11:00 P.M I replied somebody bet to fucking feed sick and tired I only ate half of a sandwich he wrote me up and gave me a write up gave me 90 days at a hearing there was not a sergeant in the room my counselor said tell the board in pass my time 80% thank you


