

1 Defendants KChloe LLC, Kelly Dowdle, and Asher Gottesman  
2 (collectively, "Defendants") and Plaintiff Chloe O'Hayon-Crosby ("Plaintiff")  
3 (collectively, the "Parties") submitted a Stipulation to Remand Removed Action  
4 ("Stipulation").

5 The Court, having read and considered the Parties' Stipulation, and good  
6 cause appearing therefor,

7 **IT IS HEREBY ORDERED THAT:**

8 (1) This action be remanded to the Superior Court of California, County  
9 of Los Angeles, Santa Monica Courthouse, Case No. SC 127909, Dept. M, the  
10 Honorable Mitchell L. Beckloff presiding;

11 (2) Regardless of this Stipulation to remand, Plaintiff's Motion for  
12 Attorneys' Fees (Dkt. 28) shall remain on this Court's calendar for hearing on  
13 January 29, 2018; and

14 (3) The Parties shall stipulate in writing, to be presented within 10 days of  
15 remand of this action to the Superior Court, a stipulation that the Proposed Second  
16 Amended Complaint be admitted to the Superior Court as the Operative  
17 Complaint.
