The vessel M/T Megacore Philomena ("Vessel") was sold pursuant to the Amended Order Authorizing Interlocutory Judicial Sale of the M/T Megacore Philomena ("Amended Order"). (Dkt. No. 264.) The public auction of the Vessel occurred on September 11, 2018. (Dkt. Nos. 348-350.) Sale of the Vessel was confirmed by Order dated September 25, 2018. (Dkt. No. 369.) The Vessel was sold to Hawkes Vigo IV at auction for \$19,000,000. The proceeds from the sale of the Vessel were deposited in the court registry pursuant to the Amended Order Authorizing Interlocutory Judicial Sale in the TMF Action. (Dkt. Nos. 349 at 14, 369).

This court granted Plaintiff TMF Trustee Limited's motion for summary judgment as to its *in rem* claims. (Dkt. No. 408.)

By order dated November 26, 2019, the Ninth Circuit affirmed the court's order of interlocutory sale of the Megacore Philomena and affirmed the court's order of summary judgment in favor of TMF Trustee Limited on its *in rem* claims. (Dkt. No. 534.) The Ninth Circuit issued the mandate on December 18, 2019. (Dkt. Nos. 539-540.)

On August 31, 2020, this Court issued an amended order granting Plaintiff TMF Trustee Limited's request for order on motion for distribution of proceeds from the sale of the vessel Megacore Philomena. (Dkt. No. 579.)

The Clerk shall disburse the remaining principal of \$16,027,712.60 plus accrued interest in the court registry from the sale of the Megacore Philomena, after deduction for expenses incurred for a wire or other means of disbursement, to TMF Trustee Limited by wire/ACH to TMF Trustee Limited.

This Court issues final judgment pursuant to Fed. R. Civ. P. 54(b) in favor of TMF Trustee Limited on its *in rem* claims and expressly determines there is no just reason for delay.
