 26 Petitioner, Secretary of Labor, United States Department of Labor (“Secretary”),  
 27 has, pursuant to Section 9 of the Fair Labor Standards Act of 1938, as amended (29

1 U.S.C. §§ 201, *et seq.* (hereinafter “FLSA”), applied to this Court for an Order requiring  
2 the Respondent, a corporation, to appear (by representative), to produce the records,  
3 papers, and documents set forth in a subpoena *duces tecum* issued by the Regional  
4 Administrator, Wage & Hour Division, U.S. Department of Labor, and duly served upon  
5 the Respondent.


6 Having considered the matters set forth in the Petitioner's pleadings herein, it is  
7 hereby

8 ORDERED that Respondent appear and SHOW CAUSE, if any there be, why the  
9 Respondent should not be ordered by this Court to comply with the administrative  
10 subpoena *duces tecum* issued to the Respondent by the Regional Administrator, Wage  
11 and Hour Division, U.S. Department of Labor on August 25, 2017, (a copy of which  
12 is Exhibit A of the Petition filed herein);

13 That the Respondent has filed and served its responsive brief[10] on  
14 February 2, 2018; and it is further

15 ORDERED that the Respondent appear at a hearing to be held on the Secretary’s  
16 Petition on March 5, 2018, at 10:00 o’clock a.m. at the United States  
17 Courthouse, in courtroom number 8D, 8th Floor, located at 350 West First Street, Los  
18 Angeles, California 90012.
