1 complaint alleging a first, second and third causes of action for breach of contract,
2 declaratory relief, and “bad faith” was set for consideration before the Court on
3 September 24, 2018 at 1:30 p.m.

5 After considering the moving, opposition and reply briefs, and the evidence
6 submitted by the parties, this Court finds that there are no genuine issues of
7 material fact as to any of the claims set forth in plaintiff’s Complaint.
8

9 Therefore, Underwriters are entitled to judgment in their favor and against
10 plaintiff in this action as to plaintiff’s entire complaint as a matter of law.

11 **IT IS ORDERED, ADJUDGED AND DECREED AS FOLLOWS:**

12 1. Defendants Certain Underwriters at Lloyd’s, London Who Subscribe
13 to Policy Numbers SS0002114/2730 and SS0002115/2566’s Motion for Summary
14 Judgment is **GRANTED**.

16 2. Plaintiff’s entire Complaint is dismissed, with prejudice.

17 3. Judgment is entered against plaintiff.
