 VERDICT**


(Verdict rendered April 17, 2019)

20 This action came on regularly for trial on April 16, 2019, in Courtroom 7A of
 21 the United States District Court, the Honorable John F. Walter presiding. Plaintiff
 22 PJAM, LLC was represented by Stephen J. Tomasulo and Clayton J. Hix, and
 23 Defendants XX Global, Inc. and Jacques Webster were represented by Howard E.
 24 King and Matthew J. Cave. A jury of 8 persons was impaneled and sworn. After
 25 hearing the evidence and arguments of counsel, and after the jury was instructed by
 26 the Court, the claims were submitted to the jury with instructions to return a special
 27 verdict. The jury deliberated and on April 17, 2019 returned a unanimous verdict.

28 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED**, that by
 reason of special jury verdict, Plaintiff PJAM, LLC is entitled to Judgment against
 Defendants XX GLOBAL, INC. and JACQUES WEBSTER in the principal

1 amount of \$382,932.79, plus prejudgment interest in the amount \$41,229.63, for a
2 total of \$424,162.42, together with recoverable costs and attorneys' fees, to the
3 extent recoverable under applicable law, and postjudgment interest at the legal rate.
