**INTRODUCTION**

1  
2 1. Defendant and Crossclaimant Keith M. Davidson (DAVIDSON) is a resident  
3 of the State of California and an Attorney who formerly represented plaintiff / counterclaim  
4 defendant Stephanie Clifford (CLIFFORD).  
5

6 2. Crossdefendant Michael D. Cohen is a resident of the State of New York and  
7 is an attorney who was adverse to DAVIDSON’s representation of CLIFFORD.

8 3. DAVIDSON and COHEN negotiated a Confidential Settlement Agreement  
9 and Assignment of Copyright involving CLIFFORD in October of 2016.  
10

11 4. DAVIDSON’S first interaction with COHEN was telephonic and began as a  
12 heated conversation with COHEN screaming at DAVIDSON about CLIFFORD’s purported  
13 efforts in selling information regarding CLIFFORD’s alleged 2007 affair with Donald  
14 Trump to the tabloid media.  
15

16 5. Though DAVIDSON and COHEN had first spoken on the phone in 2011, the  
17 two lawyers had never met face-to-face until after there were competing allegations of  
18 breach by CLIFFORD on the one side and COHEN on the other side, (roughly January of  
19 2018).  
20

21 6. The two lawyers never spoke about family, sports, politics or current events.  
22 The relationship between DAVIDSON and COHEN was professional and adversarial.

23 7. DAVIDSON and COHEN conducted the CLIFFORD negotiation via phone  
24 calls and e-mail correspondence while DAVIDSON was in California.

25 8. DAVIDSON never consulted to any of his phone calls being recorded by  
26 COHEN.

**JURISDICTION & VENUE**

1  
2 9. The court may assert personal jurisdiction over the parties because the parties  
3 have submitted themselves to this court’s jurisdiction.

4  
5 10. The court has subject matter jurisdiction under 28 U.S.C. § 1332. The parties  
6 are citizens of different states, and the amount in controversy exceeds \$75,000.00, exclusive  
7 of interest and costs.

8  
9 11. Venue is proper under 28 U.S.C. § 1391. A substantial part of the events or  
10 omissions that give rise to DAVIDSON’s claims which occurred in the Central District of  
11 California.

12 **FIRST CAUSE OF ACTION**  
13 **CIVIL VIOLATION OF THE CALIFORNIA INVASION**  
14 **OF PRIVACY ACT Cal. (Cal. Pen. Code §637 et seq.)**  
15 **AGAINST MICHAEL D. COHEN**

16 12. Plaintiff re-alleges and incorporates by reference the allegations in all prior  
17 paragraphs as though fully set forth herein;

18 13. In 1967 the California legislature enacted the California Invasion of Privacy  
19 Act for the express purpose “to protect the right of privacy of the people of this state.” *Cal.*  
20 *Pen. Code §630*. The California Legislature declared that with the advent of new devices  
21 and technology used “for the purposes of eavesdropping upon private communications,” the  
22 resulting invasion of privacy from the “use of such devices and techniques has created a  
23 serious threat to the free exercise of personal liberties and cannot be tolerated in a free and  
24 civilized society.” Sections 632 & 637 of the Act make it illegal to record telephonic  
25 communications without consent of all participants to the telephone call.

26 14. Anyone who secretly records any part to a telephone conversation with a  
27 party in California may be violating Penal Code section 632, which provides that intentional  
28 recording of any confidential communication by means of any electronic amplifying or  
recording device without the consent of all parties to the communication is guilty of a crime  
and may be subject to a civil action.

1           15. To show a violation of section 632, a party needs to show nothing more than  
2 the existence of a reasonable expectation by a party to a conversation that no one was  
3 listening in on the conversation and that the conversation was intentionally recorded by  
4 someone through the use of an electronic amplifying or recording device.

5           16. DAVIDSON is informed and believes and thereon alleges that COHEN on  
6 surreptitiously and intentionally recorded several telephone calls between he and  
7 DAVIDSON while Davidson was in California.

8           17. DAVIDSON never consented to the recordation of any phone calls he had  
9 with COHEN as he believed the calls were confidential.

10           18. DAVIDSON is informed believes and thereon alleges that COHEN's  
11 surreptitious recordation of telephonic communications between the two was contrary to  
12 California law and that the recording of the calls has caused DAVIDSON tremendous actual  
13 damages no less than the minimum jurisdictional limit of this Court.

14  
15 WHEREFORE, Defendant prays that:

- 16           1. Treble damages of no less than \$75,000.00 pursuant to Cal. Pen. Code  
17           §637.2;  
18           2. For attorneys' fees and costs of the suit herein;  
19           3. For such other relief that the Court deems just and proper.
