**ORDER RE STIPULATED
PERMANENT INJUNCTION**

Honorable Dale S. Fischer

1 Plaintiff Ford Motor Company (“Ford”), by and through its counsel, and
2 Defendant Crov Inc. D/B/A crov.com (“Crov”), by and through its counsel,
3 (together, the “Parties”), having **STIPULATED** and **AGREED** to the Court’s entry
4 of the following permanent injunction, the Court **ORDERS** as follows:

5 **STIPULATED FINDINGS**

6 WHEREAS, Ford has a pending civil action in the United States District
7 Court for the Central District of California against certain defendants, including
8 Crov, which alleges claims under the Lanham Act for trademark infringement and
9 counterfeiting, as well as unfair competition, principally related to the alleged
10 importation, distribution, and resale of allegedly counterfeit Ford-branded products,
11 Case No. 2:22-CV-05552-DSF-AGR (the “Civil Action”);

12 WHEREAS, Crov has denied Ford’s allegations in the Civil Action;

13 WHEREAS, the Parties have informed the Court that they have entered a
14 Confidential Settlement Agreement to resolve the Civil Action as between them,
15 which includes the entry of this Order re stipulated permanent injunction (the
16 “Order”), as well as the voluntary dismissal of the Civil Action with prejudice as to
17 Crov;

18 WHEREAS, Crov has stipulated to the Court’s jurisdiction over it, and has
19 stipulated to the facts necessary to establish jurisdiction over the Civil Action, for
20 purposes of entering and/or enforcing this Order and/or any other terms of the
21 Confidential Settlement Agreement; and,

22 WHEREAS, Ford has stipulated to the voluntary dismissal of Crov with
23 prejudice upon entry of this Order pursuant to Fed. R. Civ. Proc. 41(a), and has
24 informed the Court that it intends to file the same following entry of this Order.

25 **ORDER RE PERMANENT INJUNCTION**

26 Accordingly, the Court **HEREBY ORDERS** that Crov, including its officers,
27 agents, representatives, employees, and all persons and/or entities in active concert
28 or participation with any of them, who receive actual notice of this Order by

1 personal service or otherwise, shall be forever and permanently restrained and
2 enjoined from transporting, shipping, importing, storing, advertising, promoting,
3 marketing, offering to sell, selling, or otherwise distributing or facilitating the
4 distribution of any counterfeit Ford-branded product(s) and/or otherwise infringing
5 any of Ford's trademarks identified in this Civil Action.

6 The Court shall retain jurisdiction to make such orders as may be needed, if
7 any, to enforce this injunction or the terms of the settlement between the Parties.
