1 Considering the Stipulation for Disbursement of Interpleaded Funds and
2 Dismissal of Entire Action with Prejudice filed by Defendants ANTHONY KIRK
3 GREENE, SR., LINDA SINGLETON, TIFFANI KIRKWOOD, TRACIE
4 BROWN, and ANDREA KIRKWOOD (collectively, the “Parties”), the Court
5 finds, adjudges, and orders as follows:

6 1. Life Insurance Company of North America (“LINA”) filed a
7 Complaint In Interpleader (the “Complaint”) on September 1, 2023, and deposited
8 with the clerk of United States District Court, Central District of California, the
9 sum of \$305,443.53 (the “Interpleaded Funds”).

10 2. On June 14, 2024, the Court entered defendant Irene Greene’s default.

11 3. On July 16, 2024, the Court dismissed plaintiff LINA with prejudice
12 from the action pursuant to the stipulation of all parties. The Order included
13 instructions to the Clerk to issue payment to LINA in the sum of \$10,000 from the
14 proceeds deposited with the Clerk of the Court as reasonable attorneys’ fees and
15 costs incurred by LINA.

16 4. On December 6, 2024, the Court dismissed defendant Anthony
17 Greene, Jr. from the action upon granting the Parties’ Motion for Judgment on the
18 Pleadings.

19 5. The remaining defendants in this action, the Parties to this Stipulation,
20 have entered into a settlement agreement agreeing to a certain distribution of the
21 interpleaded funds.

22 The remaining parties have resolved their dispute and submitted a
23 Stipulation for Disbursement of Interpleaded Funds and Dismissal of Entire Action
24 with Prejudice, evidencing the financial terms of the settlement. Therefore,
25 pursuant to the agreement of the parties, and the record in this matter:

26 IT IS HEREBY ORDERED AND ADJUDGED that from the Interpleaded
27 Funds,

1 1. 20% of the Interpleaded Funds, calculated to be \$59,088.71, plus 20%
2 of the accrued interest, if any, be paid to defendant ANTHONY KIRK GREENE,
3 SR., by check payable to “Anthony Kirk Greene, Sr.” and delivered to Anthony
4 Kirk Greene, Sr., 15440 Sherman Way, Apt. 306, Van Nuys, CA 91406;

5 1. 40% of the Interpleaded Funds, calculated to be \$118,177.40, plus
6 40% of the accrued interest, if any, be paid to defendant LINDA SINGLETON, by
7 check payable to “Saiki Law Group APC IOLTA” and delivered to Eric H. Saiki,
8 Saiki Law Group APC, 21515 Hawthorne Blvd., Suite 200, Torrance, CA 90503;


9 2. 20% of the Interpleaded Funds, calculated to be \$59,088.71, plus 20%
10 of the accrued interest, if any, be paid to defendant TRACIE BROWN, by check
11 payable to “Interpleader Law, LLC IOLTA” and delivered to William J. Perry,
12 Interpleader Law, LLC, 5800 One Perkins Place Drive, Suite 2A, Baton Rouge,
13 LA 70808; and

14 3. 20% of the Interpleaded Funds, calculated to be \$59,088.71, plus 20%
15 of the accrued interest, if any, be paid to defendant TIFFANI KIRKWOOD, by
16 check payable to “Interpleader Law, LLC IOLTA” and delivered to William J.
17 Perry, Interpleader Law, LLC, 5800 One Perkins Place Drive, Suite 2A, Baton
18 Rouge, LA 70808.

19 4. ***INSTRUCTIONS TO THE CLERK RE DEPOSITED PROCEEDS:***
20 The Clerk shall issue payment as indicated above from the proceeds deposited with
21 the Clerk of this Court.

22 IT IS FURTHER ORDERED AND AJDUGED that this matter is hereby
23 dismissed with prejudice, with each party bearing its own fees and costs.
