**AMENDED FINAL JUDGMENT  
AGAINST RESPONDENT  
BASSAM Y. ALGHANIM**

On March 19, 2024, the Court granted Petitioner Kutayba Y. Alghanim's Petition to Confirm a Foreign Arbitration Award. Dkt. No. 45. In that Order, the Court confirmed the foreign arbitration award in the amount of \$31,360,254.36 and awarded Petitioner attorneys' fees and costs, prejudgment interest, and post-judgment interest. *Id.* at 4-5. The Court ordered Petitioner to file a motion pursuant to Federal Rule of Civil Procedure 54(d) to address the amount of the attorneys' fees and other costs that he sought. *Id.* at 5. Petitioner filed his Motion for Attorneys' Fees and Costs on March 28, 2024. Dkt. No. 47.

On May 8, 2024, the Court granted Petitioner's Motion for Attorneys' Fees and Costs. Dkt. No. 54. The Court also issued Final Judgment in favor of Petitioner and against Respondent Bassam Y. Alghanim. Dkt. No. 55.

1 On June 4, 2024, the Parties filed their Joint Submission Regarding [Proposed]  
2 Amended Final Judgment requesting that the Court amend the Final Judgment  
3 pursuant to Federal Rule of Civil Procedure 59(e).

4 Good cause having been shown and pursuant to Federal Rules of Civil  
5 Procedure 54 and 59, **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED**  
6 that an amended final judgment be entered in favor of Petitioner and against  
7 Respondent as follows:

8 Respondent shall pay Petitioner:

- 9 1. \$31,360,254.36 under the Seventh Award;
- 10 2. \$122,590 in attorneys' fees
- 11 3. \$4,847.42 in costs;
- 12 4. \$927,507.45 in prejudgment interest;
- 13 5. Post-judgment interest to accrue at the rate of 5.19% compounded  
14 annually on the unpaid amount of the judgment.


15 **IT IS FURTHER ORDERED** that, any partial payments toward satisfaction of  
16 the judgment will first be applied to post-judgment interest, if any, accrued (but not  
17 already paid) at the time of the payment, and then to the then-remaining dollar amount  
18 of the Final Judgment.

19 **IT IS FURTHER ORDERED** that, pursuant to Federal Rule of Civil  
20 Procedure 62(a), execution on this judgment and proceedings to enforce it are stayed  
21 until June 9, 2024.

22 **IT IS FURTHER ORDERED** that this Court retains jurisdiction over any  
23 matter pertaining to this judgment.

24 **IT IS SO ORDERED.**
