JUDGMENT


1 By order dated April 13, 2010, this Court granted defendant The Paul Revere
2 Life Insurance Company's ("Paul Revere") motion for summary judgment or, in the
3 alternative, partial summary judgment filed March 15, 2010 (the "Motion") in the
4 above-referenced consolidated actions.

5 The Court's decision to grant the Motion left nothing further to be decided in
6 Case No. EDCV 02-00852 VAP (SGLx) and resolved all claims and counterclaims in
7 Case No. EDCV 01-472 VAP(SGLx) with the exception of Paul Revere's
8 counterclaim for Insurance Fraud (third claim for relief) alleged in its Counterclaim
9 filed August 3, 2001. Based on the parties' stipulation, the Court has now dismissed
10 without prejudice Paul Revere's counterclaim for Insurance Fraud in Case No. EDCV
11 01-472 VAP (SGLx).

12 Having no further issues remaining for the Court decide, and consistent with
13 the Court's April 13, 2010 order granting the Motion, IT IS HEREBY ORDERED
14 that plaintiff Randy Zane ("Zane") take nothing by way of his complaints in the
15 consolidated actions, that the actions be dismissed on the merits, and that judgment
16 be entered in favor of Paul Revere forthwith.

17 IT IS FURTHER ORDERED that Paul Revere shall recover its costs and that
18 Zane shall pay Paul Revere the amount of \$63,268.33 plus interest at the legal rate.
