2 judgment as to the defendant assets subject to this forfeiture
3 complaint.

4 **WHEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:**

5 1. This court has jurisdiction over the parties to this
6 proposed consent judgment and the subject matter of this action.

7 2. The defendant assets to be forfeited or returned are set
8 out immediately below. To the extent that any asset or interest is
9 forfeited pursuant to this judgment, the United States shall
10 dispose of such asset or interest in accordance with law.

11 a. \$16,620.00 in U.S. currency is hereby forfeited to
12 the United States, and no other right, title, or
13 interest shall exist therein.

14 b. \$15,000.00 of the \$41,095.14 in bank account funds
15 shall be returned to claimant Jeremy Aleck and his
16 attorney Ronald Richards, Esq., by check payable to
17 the Law Offices of Ronald Richards & Associates and
18 shall be mailed to P.O. Box 11480, Beverly Hills,
19 California 90213. The balance of the res consisting
20 of \$26,095.14 is hereby forfeited to the United
21 States, and no other right, title or interest shall
22 exist therein.

23 c. A 2005 Land Rover, Range Rover HSE 4.4, VIN #
24 SALMF11435A191902 is hereby forfeited to the United
25 States and no other right, title or interest shall
26 exist therein.

27 d. A 2005 Ferrari F430 Coupe F1, VIN #
28 ZFFEW58A650142697 is hereby forfeited to the United

1 States, subject to a secured lien held by JP Morgan
2 Chase Bank, N.A., and no other right, title or
3 interest shall exist therein.


4 e. A Panerai Luminor Slytech wrist watch is hereby
5 forfeited to the United States, and no other right,
6 title or interest shall exist therein.

7 3. Claimants Jeremy Aleck and Lisa Ponce hereby release the
8 United States of America, its agencies, agents, and officers,
9 including employees and agents of the United States Drug
10 Enforcement Administration, from any and all claims, actions or
11 liabilities arising out of or related to this action, including,
12 without limitation, any claim for attorneys' fees, costs or
13 interest which may be asserted on his behalf, whether pursuant to
14 28 U.S.C. § 2465 or otherwise.

15 4. Each party shall bear its own costs of litigation and
16 attorney's fees. Each party waives its right to appeal. The parties
17 agree that the Court's entry of this Consent Judgment constitutes a
18 certificate of reasonable cause pursuant to 28 U.S.C. § 2465(a)(2).

19 5. The parties agree that the Court retains jurisdiction over
20 this case and the parties hereto to effectuate the terms of this
21 settlement.
