5 presented, the Court finds that there is no disputed issue of material fact remaining for
6 trial and concludes that Plaintiffs are entitled to judgment as a matter of law, and for
7 good cause shown,

8 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiffs,
9 Trustees of the Southern California IBEW-NECA Pension Plan, Trustees of the
10 Riverside County Electrical Health and Welfare Trust Fund, Trustees of the Inland
11 Empire IBEW-NECA Health Trust, Trustees of the Riverside County Educational and
12 Training Trust Fund, Trustees of the San Bernardino County Electrical Educational and
13 Training Trust Fund, Trustees of the Inland Empire IBEW-NECA Labor-Management
14 Cooperation Committee, Trustees of the National IBEW-NECA Labor-Management
15 Cooperation Committee, Trustees of the National Electrical Benefit Fund, and National
16 Electrical Industry Fund, shall recover from Defendant Pacific Electric Lighting &
17 Sound, Inc., a California corporation doing business as "W.B. Walton Electric", the
18 principal amount of \$354,708.46, plus attorney's fees of \$ _XXXXX_, and court costs
19 of \$ _XXXXX_, **IN AN AMOUNT TO BE DETERMINED**, together with post-
20 judgment interest as provided by law.
