2 Pursuant to Federal Rule of Civil Procedure 58, judgment is entered in this
3 matter on the terms set forth in the following orders:

4 Order Granting Final Approval of Class/Collective/Representative Action
5 Settlement and Awarding Attorneys' Fees, Litigation Expenses and Class
6 Representative Enhancement.

7 The Court orders the following Implementation Schedule for further
8 proceedings:

9 (a) Within seven (7) business days after the Effective Final Settlement
10 Date, Defendant will deliver the Gross Settlement Amount to the
11 Settlement Administrator;

12 (b) Within fourteen (14) business days after the Effective Final
13 Settlement Date, the Settlement Administrator will pay from the
14 Gross Settlement Amount due as follows:

15 (1) to Plaintiff, the Class Representative Incentive Award;

16 (2) to Class Counsel, the Class Counsel Fees Payments and the
17 Class Counsel Litigation Expenses Payments;

18 (3) to the responsible tax authorities, the employer share of
19 payroll taxes on the Settlement Shares;

20 (4) the LWDA payment;

21 (5) to the Settlement Administrator, its reasonable fees and
22 expenses as approved by the District Court; and

23 (6) to Participating Class Members, the Settlement Shares.
