Neither potential claimants Mendoza, Spectra Enterprises 27 nor any other potential claimant has appeared by filing a Statement identifying his 28

or her rights or interests with this Court. Further, neither potential claimants 1 2 Mendoza, Spectra Enterprises nor any other potential claimant has filed an Answer 3 to the Complaint or otherwise defended his or her interest, if any, in the defendant \$211,000.00 in U.S. currency ("defendant currency"). Therefore, the Court deems 4 5 that potential claimants Mendoza, Spectra Enterprises and all other potential claimants admit the allegations of the Complaint to be true. The Court further 6 7 finds that the allegations of the complaint establish that the defendant currency is subject to forfeiture. 8 ACCORDINGLY, IT IS ORDERED, ADJUDGED AND DECREED that 9 all right, title, and interest of potential claimants Mendoza, Spectra Enterprises and 10 11 all other potential claimants in and to the defendant currency are condemned and forfeited to the United States of America.
