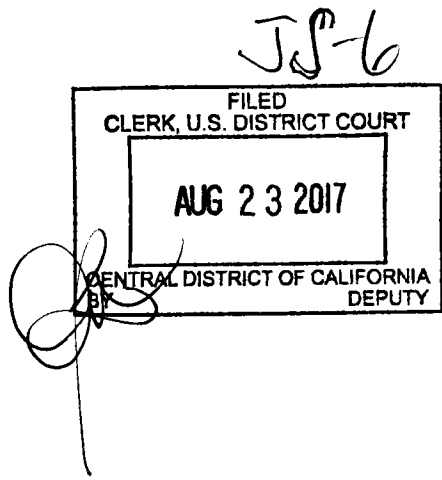

1 Based on the United States of America's motion for summary
2 judgment and for good cause shown:

3 1. Judgment is entered in favor of the United States as to the
4 interpleaded funds of \$156,104.52 deposited with the Clerk of the
5 Superior Court of the State of California for the County of San
6 Bernardino in *In re 3660 La Hacienda Drive, San Bernardino, CA*
7 *92404* (also bearing the caption *Guild Administration Corp., v. All*
8 *Claimants to Surplus Funds After Trustee's Sale of Real Property*
9 *Located at: 3660 La Hacienda Drive, San Bernardino, CA 92404*), case
10 no. CIVDS 1617088.

11 2. The California Franchise Tax Board is ordered to pay to the
12 United States the \$40,308.53 (\$40,099.89 plus \$208.64 interest) it
13 received from the Clerk of the Superior Court of the State of California
14 for the County of San Bernardino.

15 3. The Clerk of the Superior Court of the State of California for
16 the County of San Bernardino is directed to distribute to the United
17 States of America the \$116,004.63 balance of the interpleaded funds in
18 its possession plus any accrued interest the Clerk may have earned on
19 the funds.

20 4. Payments under this order shall be made payable to the
21 "United States Department of Justice" and mailed to Andrew T. Pribe,
