 17 THIS MATTER comes before the Court on Plaintiff's Application for Entry
 18 of Judgment.

19 WHEREUPON, it appearing Defendant has offered to allow a judgment in
 20 favor of Plaintiff to be entered against it, in the amount of \$2,000.00. In addition,
 21 Defendant has offered to allow a judgment for Plaintiff's reasonable costs and
 22 reasonable attorney fees incurred in this litigation to be entered against it in an
 23 amount to be agreed to by counsel for the parties or, failing agreement, in an
 24 amount to be determined by the Court; and

 26 WHEREUPON, it appearing Plaintiff has accepted Defendants' Offer of
 27 Judgment; and

1 WHEREUPON, the Court, having considered Defendant's Offer of
2 Judgment pursuant to Fed. R. Civ. P. 68, Plaintiff's acceptance of that Offer of
3 Judgment, the Court file, and being otherwise duly advised in the premises, finds
4 Judgment should be, and hereby is, GRANTED in favor of the Plaintiff in this
5 matter.


6 IT IS THEREFORE BY THE COURT ORDERED, ADJUDGED AND
7 DECREED Plaintiff shall have and recover judgment against Defendant I.C.Q.
8 SEARCH AND RECOVERY in the sum of \$2,000.00 together with interest
9 thereon at the judgment rate until paid.

10 IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE
11 COURT Plaintiff shall have and recover judgment against Defendant I.C.Q.
12 SEARCH AND RECOVERY in an amount to be agreed to by counsel for the
13 parties or, failing agreement, in an amount to be determined by the Court, for the
14 reasonable costs and reasonable attorney fees incurred in representing Plaintiff in
15 this matter.

16 IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE
17 COURT Plaintiff shall submit a Motion for Attorney Fees and Costs and any
18 desired briefing to the Court within 30 days after the entry of this Judgment.
19 Thereafter, Defendant may submit their Response, if any, to Plaintiff's Motion for
20 Attorney Fees and Costs and Plaintiff may submit her Reply, if any to Defendant's
21 Response.
