- 11 1. Plaintiffs’ Motion for Attorneys’ Fees is GRANTED as follows: Plaintiffs are
12 awarded attorneys’ fees in the amount of \$17,501.40;
- 13 2. Plaintiffs’ Motion for Costs and Expenses is GRANTED as follows: Plaintiffs are
14 awarded costs and expenses in the amount of \$18,746.91;
- 15 3. Plaintiffs are awarded a total amount of attorneys’ fees, costs and expenses in the
16 amount of \$36,248.31.
