3 3. Plaintiff Athena Cosmetics shall have judgment against defendant
4 Athena Bioscience, LLC in the amount of \$258,600. This sum consists of
5 \$250,000 as damages and restitution (based upon the evidence submitted by
6 plaintiff as to defendant's sales), and \$8,600 for attorney's fees and costs incurred
7 by plaintiff in this action.

8 4. Defendant Athena Bioscience, LLC, and its officers, directors,
9 members, affiliates and other persons, acting in concert or participation with it, are
10 permanently enjoined from in any manner infringing or contributing to or
11 participating in the infringement of the following trademarks:
