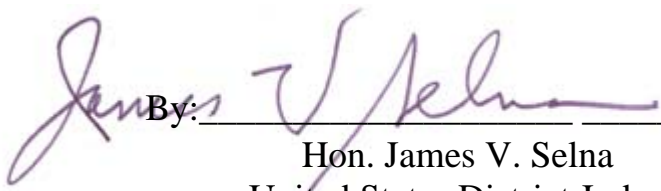
12 Costs in the amount of \$\_\_\_\_\_ are awarded.
