

3 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that plaintiffs,
4 Trustees of the Southern California Pipe Trades Health and Welfare Trust Fund,
5 Trustees of the Southern California Pipe Trades Retirement Trust Fund, Trustees of
6 the Southern California Pipe Trades Defined Contribution Trust Fund, Trustees of the
