STIPULATED CONSENT
JUDGMENT AND PERMANENT
INJUNCTION AGAINST
DEFENDANT SOLID ROCK
PRODUCTIONS, INC.; ORDER THEREON.

1 Plaintiff David Di Sabatino ("Di Sabatino") and defendant Solid Rock
2 Productions, Inc. ("Solid Rock"), consenting to personal jurisdiction, subject matter
3 jurisdiction, and venue in this District Court, and pursuant to the Stipulation for Entry
4 of Consent Judgment and Permanent Injunction filed in this action, hereby stipulate
5 and consent to the entry of the following Consent Judgment and Permanent Injunction
6 ("Consent Judgment") against Solid Rock.

7 IT IS HEREBY ORDERED AND ADJUDGED THAT:

8 1. This Court has jurisdiction over the subject matter of this action and the
9 parties thereto.

10 2. The subject of this action and this Judgment is a documentary film
11 produced by Di Sabatino entitled *Fallen Angel: The Outlaw Larry Norman* as
12 exhibited at the Cinequest film festival on March 1-4 and 6, 2009, a dvd copy of which
13 is attached to this Judgment and incorporated herein by reference (hereinafter the
14 "Documentary").

15 3. The Documentary does not infringe any copyrights Solid Rock may own
16 in works that are contained in the Documentary.

17 4. Solid Rock has no and may assert no privacy claim regarding the
18 Documentary.

19 5. Solid Rock and its officers, directors, agents, servants, employees,
20 shareholders, successors and attorneys, and all those persons in active concert or
21 participation with them who receive actual notice of this Consent Judgment by
22 personal service or otherwise, are hereby enjoined and restrained from:

23 a. asserting copyright claims in connection with the Documentary
24 against Di Sabatino and/or any third party acting in concert with Di Sabatino to
25 reproduce, sell, distribute, exhibit, promote or otherwise exploit the Documentary;
26 and/or;

1 b. asserting any privacy claim in connection with the Documentary
2 against Di Sabatino and/or any third party acting in concert with Di Sabatino to
3 reproduce, sell, distribute, exhibit, promote or otherwise exploit the Documentary.


4 6. In the event Solid Rock, or any of its officers, directors, agents, servants,
5 employees, shareholders, successors and attorneys, and all those persons in active
6 concert or participation with them who receive actual notice of this Consent Judgment
7 by personal service or otherwise violate any of the terms of this Consent Judgment, Di
8 Sabatino shall be entitled to immediately seek, with or without notice to Solid Rock,
9 an order to show cause as to why an injunction should not issue to prohibit such
10 violation..

11 7. Notwithstanding any contrary provisions of the Federal Rules of Civil
12 Procedure, and notwithstanding the absence of any findings of fact and/or conclusions
13 of law by this Court, any requirements for which have been expressly waived by Di
14 Sabatino and Solid Rock, this Consent Judgment is a final judgment in this action and
15 suitable for entry by the Clerk pursuant to Fed. R. Civ. Proc. 58 and 79(a). All rights
16 to appeal this final judgment, on any basis, have been expressly waived by Solid Rock.

17 8. Each side is to bear its own attorneys' fees and costs incurred in this
18 action.
