**[PROPOSED] ORDER REGARDING  
 CONTINUATION OF SETTLEMENT  
 CONFERENCE, PRETRIAL  
 CONFERENCE AND TRIAL DATES**

1 Pursuant to Federal Rule of Civil Procedure 16(b)(4) and Local Rule 16-9, having  
2 considered the stipulation of the parties, the record on file in this action, and good cause  
3 appearing, IT IS HEREBY ORDERED THAT:

4 1. The schedule set forth in the Civil Minutes regarding the Scheduling  
5 Conference, dated August 10, 2009, and the Order for Jury Trial, dated August 11,  
6 2009, shall be modified as follows:

7 (a) The parties shall file motions *in limine* no later than June 28, 2010,  
8 or such other time that the Court deems appropriate;

9 (b) The parties shall file pretrial documents no later than July 12, 2010,  
10 or such other time that the Court deems appropriate;

11 (c) The Final Pretrial Conference shall be set for July 19, 2010 at 11:00  
12 a.m., or such other time that the Court deems appropriate;

13 (d) The trial shall be set for August 3, 2010 at 8:30 a.m., or such other  
14 time that the Court deems appropriate;

15 2. Within seven (7) days following the entry of the Court's order deciding the  
16 parties' cross-motions for summary judgment, the parties shall contact the Magistrate  
17 Judge to schedule a settlement conference; and

18 3. The parties shall file all necessary documents and complete such settlement  
19 discussions no later than thirty (30) days following entry of the Court's order deciding  
20 the parties' summary judgment motions, subject to the availability of the Magistrate  
21 Judge and any further order of the Court.
