**[PROPOSED] ORDER REGARDING
 SCHEDULING OF SETTLEMENT

1 Pursuant to Local Rule 16-15.4, having considered the stipulation of the parties,
2 the record on file in this action, and good cause appearing, IT IS HEREBY ORDERED
3 THAT:

4 1. The parties shall appear for a settlement conference before the Magistrate
5 Judge on Thursday, July 8, 2010 at 9:30 a.m.;

6 2. Plaintiff Henley, who resides outside the District, shall be excused from
7 personal attendance of the settlement conference, pursuant to paragraph 7 of the Court's
8 Order Re Settlement Conference. Henley shall be available by telephone for the
9 duration of the conference, and his counsel shall personally attend the conference with
10 full authority to act on his behalf;

11 3. Defendant Hart, who resides outside the District, shall be excused from
12 personal attendance at the settlement conference, pursuant to paragraph 7 of the Court's
13 Order Re Settlement Conference. Hart shall be available by telephone for the duration
14 of the conference, and his counsel shall personally attend the conference with full
15 authority to act on his behalf; and

16 4. Defendant DeVore, who expects to be in session with the California
17 Assembly, shall be excused from personal attendance at the settlement conference,
18 pursuant to paragraph 7 of the Court's Order Re Settlement Conference. DeVore shall
19 be available by telephone for the duration of the conference, and his counsel shall
20 personally attend the conference with full authority to act on his behalf.
