**JUDGMENT AND PERMANENT  
INJUNCTION**

21 The court, having considered the papers and pleadings on file herein, and  
22 based on the evidence and argument presented by plaintiff Joymax Co. Ltd, and  
23 pursuant to the "Order Granting Plaintiff's Application for Entry of Default  
24 Judgment in Part,"

25 **IT IS ORDERED AND JUDGMENT SHALL BE ENTERED AS  
26 FOLLOWS:**

27 1. Default judgment shall be entered in favor of Joymax Co., Ltd. and  
28 against Grzegorz Grycuk, ECSRO and ECSRO.NET.

2. Joymax Co., Ltd. shall recover statutory damages, based upon willful  
infringement of copyright, pursuant to 17 U.S.C §504(c)(2), in the amount of  
\$75,000.

1           3.     Joymax Co., Ltd. shall recover costs of suit, pursuant to 17 U.S.C.  
2 §505, in the amount of \$4,750.

3           4.     Joymax Co., Ltd. shall recover attorneys fees, pursuant to 17 U.S.C.  
4 §505, in the amount of \$28,050.

5           5.     Defendants Grzegorz Grycuk, ECSRO and ECSRO.NET, and all  
6 persons and entities acting in concert with those defendants, are hereby  
7 permanently enjoined from operating any computer, server or other electronic  
8 device in conjunction with any version of the copyrighted Silkroad Online Server  
9 software and are further enjoined from offering or purporting to offer the sale or use  
10 of any gold, silk, weapons, armor or other character enhancing token or device for  
11 use in conjunction with Silkroad Online.

12          6.     Pursuant to 15 U.S.C. §1125(d)(ii)(C), and pursuant to the applicable  
13 ICANN rules relating to the reassignment of domain names, it is hereby Ordered  
14 that the current registrar for the domain name www.ecsro.com shall be reassigned  
15 to plaintiff Joymax Co., Ltd. and this court will retain jurisdiction to issue any  
16 necessary supplemental orders, addressed to the registrar or other authority, upon  
17 appropriate showing of necessity by Joymax Co., Ltd.

18           IT IS SO ORDERED, ADJUDGED AND DECREED THIS 12th DAY OF
