Dear Dean:

We are in receipt of your letter dated May 12, 2011 regarding the July 19-22 depositions of Will Adams, Stacy Ferguson, Alan Pineda and Jamie Gomez.

As previously indicated, we agree to the depositions over the dates provided. However, we will not agree to dual tracking of these depositions as your letter suggests. Seven hours on the record with each deponent should be sufficient to gather full and complete responses to all your questions with respect to both the *Batts* and *Pringle* lawsuits. To the extent more time is needed, we are open to discussing additional dates in the Fall.

With respect to your suggestion that the parties retain a single reporting firm and share the cost *pro rata*, we decline that proposal. Finally, while you previously noticed these depositions for George Hampton's office in Newport Beach, that location is unduly burdensome for the deponents, each of whom resides in Los Angeles. We will agree to hold those depositions at Bryan Cave's Los Angeles office, located at 120 Broadway in Santa Monica.
