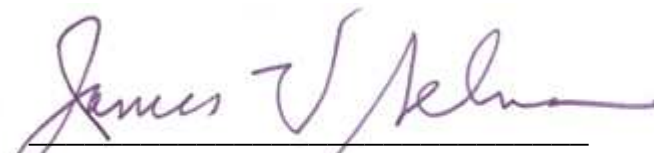
1 **FINAL JUDGMENT**
