On July 1, 2014, Bienert, Miller, & Katzman filed a Motion to Withdraw as Counsel for Defendants WDE Solution, Inc. ("WDE") and Bollington Enterprises, Limited ("Bollington") (Dkt. 161). On July 30, 2014, the Court entered an Order Granting Motion to Withdraw (Dkt. 181).
