 22 Based on the Stipulation to Resolve the Interpleader and Distribute the  
 23 Remaining Funds (“Stipulation”), and for good cause shown, the Stipulation is  
 24 GRANTED.

25 **IT ORDERED** that the Clerk of the Court shall distribute the amounts currently on  
 26 deposit as follows:

1 First, \$304,908.98 to the United States to be applied to the employment and  
2 unemployment tax liabilities of Fiberco.

3 Second, \$100,000.00 to the United States to be applied in the best interests of  
4 the government in partial satisfaction of the income tax liabilities of David Zuniga.

5 Third, the remaining \$143,191.59 plus interest to Fiberco.
